Jamestown Chamber of Commerce Minutes for Board of Directors Meeting Thursday, May 2, 2019 5:00pm Conanicut Brewing

- 1. Call to Order: Claudine called the meeting to order at 5:06pm.
- 2. **Guest:** Erin Donovan-Boyle gave a presentation on recent happenings with the Newport County Chamber of Commerce, their new facility, and the potential to collaborate on a joint shared-workspace project at 24 Narragansett Ave. The Board feels this could be a future agenda item depending on membership interest.
- 3. **Guest:** Police Chief Mello gave a presentation on the proposed changes to the parking ordinances. Maps and a hard copy of the marked-up regulations were provided. Signage needs to improved for current lots, consistency, and a balance between high-turnover and all-day parking needs to be established. There was clarification on current monitoring and potential future methods to be used in the downtown area. Bill Munger expressed concerns about maintaining sufficient longer-term parking for boaters, workers, and others who come to enjoy Jamestown and the harbor area for the day.

- 5. **Minutes of April's Meeting**: Previously emailed, in a timely manner, by Ben. A general motion was made to accept. Bill, naturally, seconded. Iain was a distant third. All were in immediate and vociferous favor.
